# 1. What Personal Information We Collect

We may collect the following types of personal and sensitive information:

- Identity & Contact Information name, date of birth, address, phone number, and email
- Health Information medical history, treatment notes, referral details, and other information relevant to your care
- Appointment & Billing Information appointment history, Medicare or health fund details, and payment information
- Other Information any additional details you provide voluntarily during consultation or through forms

2. How We Collect Your Information

We usually collect your personal information:

- Directly from you (in person, by phone, email, or through our website)
- From third parties with your consent (e.g. GP referrals, other health professionals)
- When you use our services or complete forms (online or in clinic)

3. Why We Collect Your Information

We collect and use your personal information for the following purposes:

- To provide safe and effective osteopathic care
- To maintain accurate medical records
- To communicate with you about your appointments or treatment
- To manage billing, payments, and health fund claims
- To comply with our legal and regulatory obligations

4. How We Store and Protect Your Information

Your information is stored securely in both electronic and physical formats. We take reasonable steps to:

- Protect your data from misuse, loss, or unauthorised access
- · Limit access to personal information to authorised personnel only
- Use secure software and encryption where appropriate

We are required to retain certain records (e.g. treatment notes) for a minimum period under health regulations.

#### 5. When We Disclose Your Information

We will not share your information without your consent, except when required or authorised by law. We may disclose information to:

- Other healthcare providers involved in your care (with your consent)
- Health insurers, Medicare, or third-party payers (for billing purposes)
- Regulatory bodies, if legally required (e.g. under a court order)
- Our practice management or IT providers (under confidentiality agreements)

6. Accessing and Correcting Your Information

You have the right to:

- Request access to the personal information we hold about you
- Request corrections if you believe your information is inaccurate or incomplete

Requests can be made in writing, and we will respond within a reasonable time, usually within 30 days.

- 2. Cancellations & No-Shows
- We require a minimum of 10 hours notice to cancel or reschedule an appointment.

- Failure to attend without notice ("no-show") may result in a full consultation fee being charged.
